I am the authorized representative identified above, and I have control of the premises also identified above either because 1) I am an owner of the premises or 2) I have lawful authority over the premises sufficient to make this authorization.

I authorize the Beaverton police department and its officers to act as my agent for the purpose of excluding individuals from the premises according to the attached exclusion criteria. I further authorize the Beaverton police department and its officers to act as my agent to enforce trespass laws against individuals who unlawfully enter or remain on the premises.

Unless I direct otherwise, an individual who engages in conduct constituting grounds for exclusion may be excluded from the premises for one year. An individual who fails to leave the premises after being directed to do so by a police officer or other person in charge, or who has been excluded but returns before the exclusion has ended, is

subject to arrest and prosecution for criminal trespass under ORS 164.245 or Beaverton Code 5.08.405. If the excluded individual does not return to the premises for one year, the exclusion will expire.

My intent by this authorization is to empower police officers of the Beaverton police department to become a "person in charge" of the premises consistent with how that term is defined in ORS 164.205(5). The officers hold this authority over the premises as my agent while acting on duty in their capacity as peace officers.

My authorization does not establish any sort of special duty or relationship between me, the Beaverton police department, its officers, or the premises. The police department and its officers are not required by this authorization to act on my behalf to exclude people from the premises or to arrest people for trespass to the premises.

My participation in this arrangement is voluntary. I have used my own judgment to decide if this arrangement is right for my business, and I have considered whether to discuss the program with my own legal advisor to help determine if this arrangement is suitable for my circumstances.

This authorization does not diminish my ability to control the premises. I remain a person in charge of the premises. This delegation of authority does not prevent the exercise of any other rights or remedies I have or that may subsequently be available to me.

The authorization to exclude individuals begins upon delivery of this signed authorization to the Beaverton Police Department. The authorization remains in effect until canceled by a party.

I have the power to revoke this authorization at any time. If I decide to terminate this authorization or if the ownership or management of the premises changes, I will notify the Beaverton police department in writing and remove any evidence of my participation in this program from my business. The Beaverton police department also may terminate this authorization and it will notify me of that decision in writing, and I will then promptly remove any evidence of my participation in this program from my business.

If I wish to modify or rescind an exclusion imposed upon an individual by a police officer, I will promptly notify the Beaverton police department of my decision, so to reduce confusion over an individual's exclusion status. Likewise, I understand that the police department provides a process for excluded individuals to have their police-officer imposed exclusions reviewed. Because of that process, a one-year exclusion may be modified or rescinded. If the department modifies or rescinds such an exclusion that affects my premises, the department will notify me of that decision.

## CRITERIA FOR EXCLUSION FROM THESE PREMISES CRITERIOS DE EXCLUSIÓN DE ESTAS PREMISAS

A person may be directed to leave and not return to these premises if while on these premises the person does, or is reasonably suspected of doing, any of the following / *Una persona se le puede ordenar que se vaya y no regrese a estas instalaciones si mientras está en estas instalaciones la persona hace, o se sospecha razonablemente que está haciendo, cualquiera de las siguientes cosas:*

1. Making unreasonable noise / *Hacer ruido irrazonable.*
2. Engaging in fighting or violent, tumultuous, or threatening behavior. / *Participar en peleas o comportamientos violentos, ruidosos o amenazantes.*
3. Violating any criminal provision of the Oregon Revised Statutes or Beaverton City Code. / *Violar cualquier disposición penal de los Estatutos Revisados de Oregon o del Código de la Ciudad de Beaverton.*
4. Remaining for more than 20 minutes on the premises for reasons not related to the operation of the business. / *Permanecer más de 20 minutos en el local por motivos no relacionadas con el funcionamiento del negocio.*
5. Violating any applicable curfew. / *Violar cualquier toque de queda applicable.*
6. Unlawfully consuming or possessing alcohol or a controlled substance. / *Consumir o poseer ilegalmente alcohol o una sustancia controlada.*
7. Littering. / *Tirar basura.*
8. Skateboarding. / *Uso de Patinetas.*
9. Damaging, defacing, or destroying any property belonging to this premise, its employees, or customers. / *Dañar, desfigurar o destruir cualquier propiedad perteneciente a esta premisa, sus empleados o clientes.*
10. Driving a vehicle on the premises in a careless or reckless manner. / *Conducir un vehículo en las instalaciones de manera descuidada o imprudente.*
11. Unlawfully possessing a firearm. / *Poseer ilegalmente un arma de fuego.*
12. Obstructing vehicular or pedestrian traffic. / *Obstruir el tráfico de vehículos o peatones.*
