The first hearing in a case can come within hours of an arrest. If you are concerned about someone's release from custody after an arrest, contact your District Attorney's office, City Attorney's office or Juvenile Department immediately.

#### You have the right to...

- a support person
- be treated with dignity and respect
- reasonable protection from the offender
- fair and impartial treatment
- a meaningful role in the justice process

#### If the state pursues criminal prosecution, you have the right to...

- **Speak** at the pre-trial release hearing
- **Request** a court order to keep the defendant from contacting you
- **Keep** your phone number and address from the defendant
- **Request** certain conviction, criminal history, and imprisonment information
- **Request** an HIV test of the defendant if the crime involved transmission of bodily fluids
- **Request** notice of court proceedings before they take place. You may attend open court proceedings even if you don't ask beforehand

- **Choose** to give or refuse to give information to an attorney or private investigator working for the defendant or alleged youth offender
- **Have** the court consider your schedule if a trial date is set
- **Request** that the district attorney consult you about a plea offer in a violent felony case
- **Request** a transcript of open court proceedings

#### If the alleged youth offender or defendant is convicted, you have the right to...

- **Be present** at sentencing or disposition and give a victim impact statement
- **Receive** restitution

#### You may have additional legal options if you are victim of...

- disabled person abuse
- family abuse
- elder abuse
- sexual assault
- stalking
- OR if you are an immigrant who is a victim of a crime
